This past year has been unlike any other, and the NJDOE believes that it is critical to use the available data in the reports, along with other information collected directly within districts and communities, to start conversations, identify gaps in information, and begin to find ways to address the impacts of COVID-19 and ensure all students receive the support that they need.

- Student growth Data
- Chronic absenteeism rates
- Progress toward English language proficiency

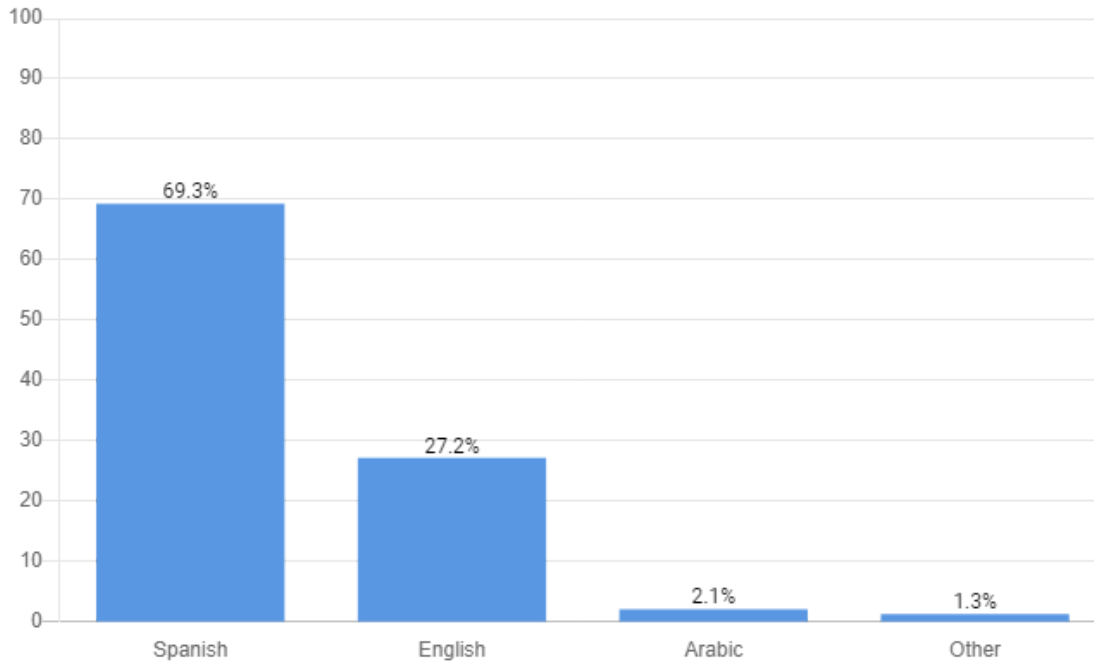

Student Growth

Student growth is a measure of how much students are learning each year. Each student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7 that explains their progress compared to students who had the same test scores in previous years.

A student's SGP falls between 1 and 99 and can be grouped into three levels:

Low Growth: Less than 35

Typical Growth: Between 35 and 65

High Growth: Greater than 65

If the student growth percentiles for all students in the school are ordered from smallest to largest, the median student growth percentile (mSGP) for the school is the percentile in the middle of that list. 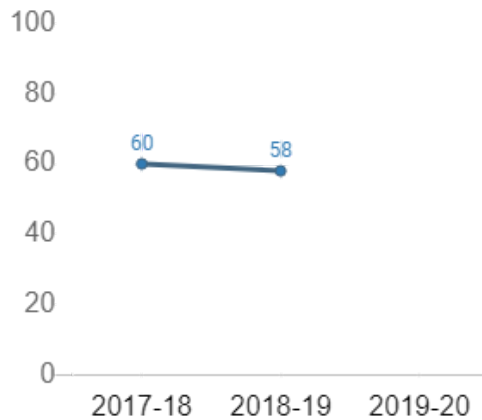

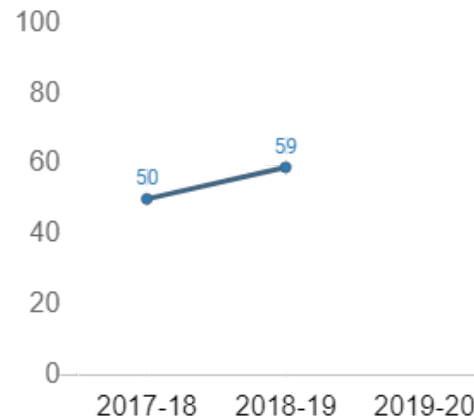

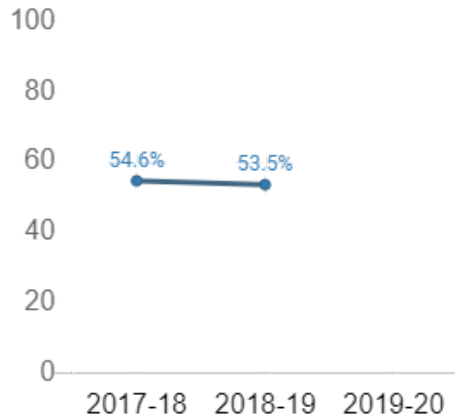

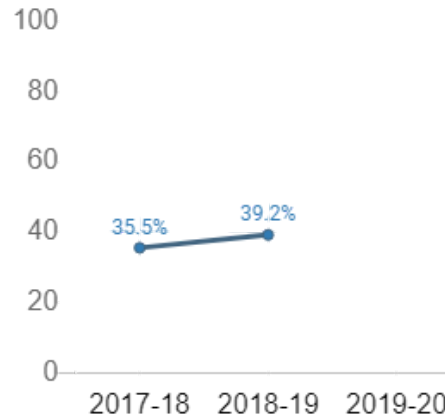

The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

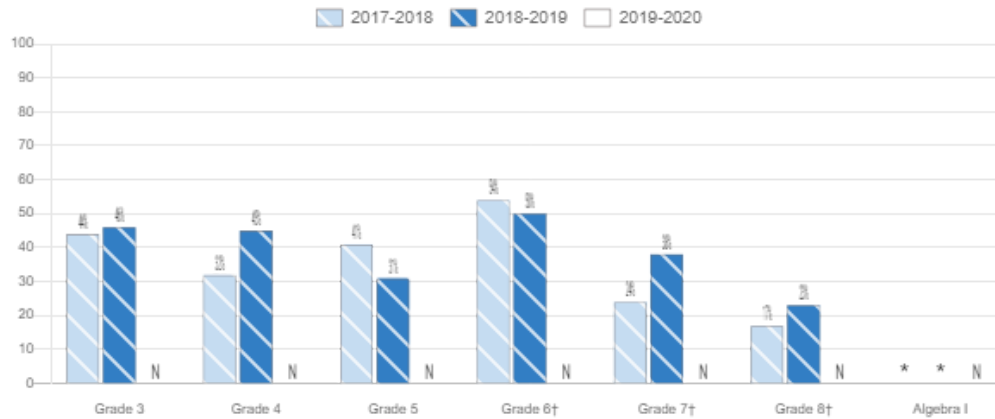
Mathematics Assessment – Performance Trends

DLM Alternate Assessment - Participation

English Language Progress to Proficiency

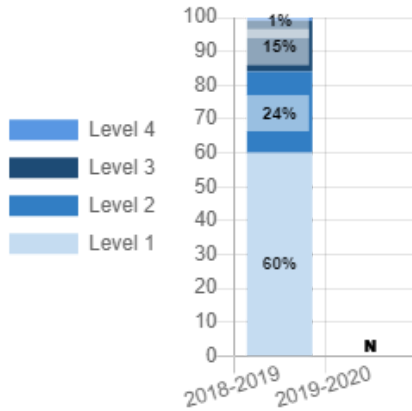

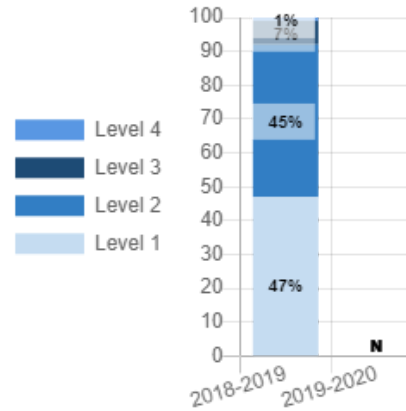

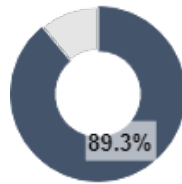
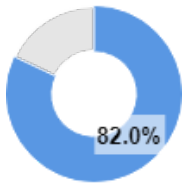

Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The New Jersey Department of Education used input from New Jersey communities to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Important Note for 2019-20: Due to the COVID-19 pandemic, NJDOE received a federal waiver which removed the requirement to report on chronic absenteeism and related accountability measures for the 2019-20 school year. As a result, NJDOE will not report on chronic absenteeism and other attendance data for 2019-20. Tables showing 2019-20 attendance data will be hidden in this report.

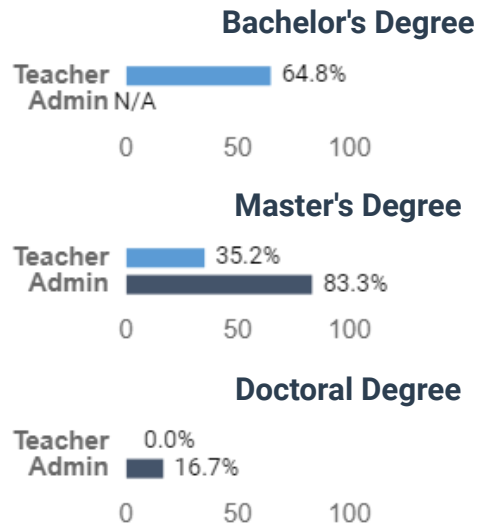

Important Note for 2019-2020: Due to the COVID-19 pandemic, New Jersey received a [waiver from the United States Department of Education \(USED\)](#) in March 2020 to waive statewide assessment, accountability, and reporting requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 school year. This removes the requirement to:

- Calculate indicator scores and summative scores for the 2019-2020 school year;

For the annual identification of schools for Targeted Support and Improvement: Consistently Underperforming Student Group, no schools will be identified during the 2020-2021 school year as a result of the March 2020 waiver. New Jersey has submitted a request to USED to waive the next identification in the 2021-2022 school year due to the lack of two consecutive years of data.

The school is equipped with eighty-two cameras covering both external and internal areas of the school and grounds. The front vestibule areas of both the original school building and new school building are equipped with "Lexan" glass that is bullet resistant. The Anna L. Klein School collaborates with local law enforcement agencies and runs all mandated drills. In addition, the Anna L. Klein school permits the Hudson Cty. Prosecutors Office and SWAT team to conduct real world exercises/drill in the school to ensure that both law enforcement and school personnel are ready in the event of a real-life threatening situation. In addition, the LEAD program, Law Enforcement Against Drugs is taught by the Guttenberg Police Department.



1:1 Chromebooks for all students kindergarten through 8th grade. There are SmartBoards and/or Promethean boards in all classrooms. Special Education students use ouch I-Pads for learning. Document cameras are available for all teachers to use for instructional purposes. The WIFI, access points, and broadband coverage has been updated and strengthened for virtual and live instruction. We have a state of the art STEAM lab complete with hands-on resources and materials. STEAM classes are also taught in the primary grade levels.

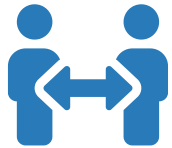

Learning During COVID-19:

COVID Learning has changed the way in which we teach, learn, and the overall function of the school district during the end of the 2019-2020 and the 2020-21 school year. The Guttenberg Pandemic Response Team and the Re-Opening Team met to create a streamlined approach to teaching under COVID conditions. These teams worked on creating an effective school schedule that ensured a successful academic and safe school program. This plan also included a focus on the social-emotional well-being of our students. Each student in all grades was given a Chromebook to take home to enable them to access Google classroom, which during COVID has been the primary means of instruction.
